Ambulance Demonstration & Concert Sept 15th Several members of the Brigade having by examination entitled themselves to receive certificates and medallions 90. The subject was brought forward that in recognition of the great good the St John Ambulance were doing in the town the V.L.B. ought to support it in whatsoever means possible-after considerable discussion the following resolution was adopted

Proposed by Capt. G. Robson 2nd by Mr John Robe that "The Brigade attend the Concert and Demonstration & the expenses & the cost of some little refreshment for each member be found by the Brigade" _ There was a long discussion about the best means of lighting the Brigade House with the gas which had just been introduced _ It was finally left in the hands of the House Committee assisted by Mr J.H. Wood to confer with Messrs Dagleas & Sons (who had already attended to the connection with the main) as to the best means to be taken_ The House Committee accordingly held a meeting with Mr Dagleas & after going into the matter very carefully, made the necessary arrangements as they now stand & the work has since been carried out.

Mr Richard Williamson 79 Broderick St was then elected a member & an application from a Mr W. Anderson was deferred till next meeting.

Committee Meeting held in Brigade House October 3rd 1891

COMMITTEE MEETING HELD IN THE BRIGADE HOUSE NOV 7^{TH} 1891

The minutes of the previous meeting were read and on the motion of Mr Vasey and 2nd by Capt. Robson were confirmed.

The Secretary of the Ambulance Class (Mr Page) reported that a meeting had been held with a view to form a fresh class for this winter but only 7 had attended –it was resolved that another meeting be called and if sufficient names could be got a new class should be formed

It was proposed and carried that the Brigade pay the Rent for the Meter fixed at the commencement of the Pier until such times as the Commissioners begin to use it themselves

It was proposed that Mr G. R. Potts be deputy Treasurer during Mr Malcolm's absence from home.

Committee Meeting held Dec 5th 1891

Capt. Robson in the Chair

Mr Webb Peploe was proposed and balloted for as a member and elected another application for Mr W. Mitford was ordered to wait till next meeting as he was not known to any member of the Committee. The following a/cs were passed Dagleas for Plumbing work in connection with fitting the house with gas-Meter Rent to Gas Company. Ground Rent to Commissioners.

It was proposed by Capt. Ross and 2nd by Mr John Robe that the model lifeboat made by the late Dep. Capt. Birch should be lent to Mr Ambrose Flagg to illustrate the different types of lifeboat built- This was carried.

COMMITTEE MEETING HELD FEBRUARY 6TH 1892

Sundry a/cs were presented to the Committee and passed

Ten applications for membership were submitted but on looking at the Roll Books it was found that each Division was up to full strength so it was decided that the applications be held over for the present.

It was proposed by Capt. Ross seconded by Dep Capt. Thompson that a letter of thanks be written to Supt. Farmer for his kindness in allowing the constables of his force to come and assist in keeping order at the late wrecks-Carried.

The subject of the Church Parade being discussed it was proposed by Capt. Potts and seconded by Capt. Ross that we have this Parade as proposed and if possible arrange to have the Wellesley band to play us to church-Mr Farrar being in waiting to hear what was decided, he was asked to come into the room & explain his views & wishes-After hearing Mr Farrar it was unanimously decided to attend the Seaman's Mission Church on Sunday Feb. 28th and that the collection be given to the National Lifeboat Institution – Brigade to muster at 10.15 on Sunday morning.

An application was read from the Secretary to the Sailors Union asking to be allowed to attend the Watch House after a wreck so as look after any of a shipwrecked crew who may happen to be members of their Union-After some little discussion it was allowed that the Secretary or his Deputy be admitted to the House at any time and that every facility be given him to allow him to remove any of his men as soon as possible.

The behaviour of James Mitchelson at the wreck of the "Huntsman" having been brought before the Committee by Capt Robson it was decided that he be written to and requested to appear at the next Committee meeting to be held March 5th to answer to certain charges of insubordination to orders and impertinence to Capt. Robson and that the Committee shall hear his statement and after that either reprimand him or take any other course of action they may think fit-Carried.

COMMITTEE MEETING HELD MARCH 5TH 1892

The minutes of last meeting were read and confirmed -The question of Mr Michelson's

behaviour at the wreck of the "Huntsman" relative to a charge made against him by Capt. Robson of disobedience of orders & insolence- Mr Mitchelson having written a long letter of defence and explanation the same was read to the Committee when it was decided that Mr Mitchelson be called into the room, censured for his conduct & asked to apologise to Capt. Robson-This he eventually did and the matter finished.

The minutes of the last Committee meeting were read & confirmed.

The different places spoken of for trip were discussed & it was settled that the Secretary should write to the N.C.R. asking what trips they intended running during July & August and intimating that we probably would require about 150 tickets- The answer from the Company was posted in the House as requested and is to the effect that they could not inform us how they intended to run their trips as they were arranged from time to time to suit the requirements of the traffic.

The next question was painting the Brigade House when it was proposed by Dep. Capt. Wood & 2nd by Mr Newby that tenders be advertised for to paint the outside of the house-2 coats of Paint

It was decided that the Secretary prepare a list of Wrecks which have taken place since the last printed list was published and have it mounted in a frame & hung in the house & that the Board of Trade be written to & asked to send us a further supply of belts-It was after a little discussion decided to leave the details of the arrangement of the painting &c. in the hands of the House Committee.

ANNUAL MEETING, JULY 14TH 1892

Capt Potts in the Chair

The minutes of last Annual meeting were read and confirmed. Proposed by Mr Thomas Vasey & 2nd by Mr John Brown Scrutineers new then appointed to examine the voting papers. They were Messrs Jas Robertson, R. Alexander, R. Bell & Mr Stainton

The Assistant Sec. Capt. Buckland then read the Secretary's report which report he explained had been sent to the Secretary (then in Switzerland) for his revision and approval. It was then moved by Mr Vasey & 2nd by Mr Grimes that the Secretarys report be adopted, printed & circulated among the members. Mr Potts (acting for Treasurer) then read the treasurers report.

It was moved by Capt. Robson & 2nd by Mr Bell that the report b adopted and printed as usual. It was mentioned by several members that they thought the Treasurers report ought to be circulated among the members before the Annual meeting so as to give it a chance of being discussed. WRECK OF THE "JACOB ROTHENBURG" OF ROSTOCK

Sir,

I have the honour to acknowledge the receipt of your letter of the 30th last addressed to Captain Whitelaw requesting to be furnished for the information of the German Authorities with a statement of the facts in connection with above shipwreck as far as regards the operations of the South Shields Volunteer Life Brigade.

The vessel lights were first observed by the Brigadesmen on duty about 5.30 a.m. Nov <u>27</u> 26 and her movements were watched with great anxiety as it was seen from her position, there would be great difficulty in weathering the South Pier. In a short time she struck the staging at the end of the Pier carrying away her Foremast and Bowsprit and about 6.15 A.M. stranded on the South side of the pier at a distance of 50 yards there from.

In anticipation of this the Brigadesmen who had been on duty all night had taken the Rocket Apparatus along the Pier and had everything in readiness. The first rocket carried the line over the Bows, but the sea was washing right over the vessel and the crew in consequence appeared unable to get to it. A second line was thrown over the main top gallant yard. This the crew failed to reach. A third line was fired on board which landed across the rigging in a similar position. An attempt was then made to fire a line on to the deck within reach of the crew who had taken refuge aft, but owing to the nature of the Pier and the difficulty of adjusting the Rocket. It fell short. After this one of the crew managed to go aloft and get hold of one of the previous lines by which they soon hauled our apparatus on board making the gear fast to the mizan mast. During all this time heavy seas were breaking over the ship and we had grave fears that the other Masts might fall. However without any mishap and in about 20 minutes from the seaman getting the Rocket line the whole of the crew, 7 in number together with the English Pilot were safely landed. They were taken to our Watch House where they received by the medical officer of the Brigade and supplied with warm clothing and refreshments.

The above is a short recal of the facts as seen by Captain Whitelaw from the beginning and also by myself from the firing of the second rocket. I may also state that Captain Prowse R. N. Her Majesty's Inspecting General of Life Saving Apparatus happening to be here on an official visit was present at the wreck and witnessed the saving of the crew.

Permit me in conclusion on behalf of the members of South Shields Volunteer Life Brigade and the officers of the Coastguard to thank you in return for your kind remaeks as to what was done for the crew of the "Jacob Rothenburg" and state that we always fell amply awarded rewarded for our trouble, when successful in saving the lives of our fellow man of whatever nationality, and especially those of a nation so closely allied to our own.

LIGHTS USED AS LIFESAVING SIGNALS

South Shields Jan 22 1879

Sir,

I have the honour to acknowledge the receipt of your letter NT 18874 enclosing a copy of a letter received from the Secretary of the Tyne Lifeboat Fund suggesting certain alterations in the present system of Lifesaving Signals and requesting to be favoured with my observations thereon.

In reply I may state at the outset that the present arrangement was established for the convenience and information of the Tynemouth and South Shields Life Brigades any 2 guns fired for a vessel ashore on N side of the harbour and 3 for the South side. As these signals in certain minds were indistinctly heard it was subsequently arranged that HMS "Castor" lying in the river should repeat the same. This as far as the Brigades are concerned has been found to work very well except that the general public are also at the same time informed that a disaster has occurred and crowd down to the Piers sometimes to the great inconvenience of Members working the Rocket Apparatus.

Previous to the foundation of our Brigades it was the custom of the Pilots to keep a look out in stormy weather and to judge for themselves the advisability of manning the lifeboats. Since then, with some exceptions they appear to depend upon the signals and as soon as they are heard the Boats are manned, not because they may be wanted but because the guns have been fired thereby throwing the onus of the cost to the Life Boat Fund on the present system of signals.

Last year an attempt was made to remedy this by fixing a mast close to our Watch House so that by hoisting certain lights the man in charge could indicate whether the vessel was inside or outside the So. Pier. This is a step in the right direction and should be persevered with until it has had a fair trial.

I think it would be unwise to complicate the present arrangement as suggested. The only alteration that might be attempted would be not to fire the Guns when the coastguard Official in charge thinks he has sufficient assistance to work the apparatus.

In making these remarks I must at the same time it is and always has been my wish that both these institutions should work together harmoniously and what tends to the efficiency of one should not be at the inconvenience of the other.

I shall be glad to have a further reply to my letter of Dec. 3rd 1878.

LETTER FROM MALCOLM TO THE EDITOR OF THE SHIELDS GAZETTE

Shields Daily Gazette 6 Nov 1880

SOUTH SHIELDS VOLUNTEER LIFE BRIGADE

We print letter to-day from the Secretory of the South Shields Volunteer Life every word of which we endorse. The public we are certain, need only to be reminded of their duty towards the gallant body organised for the rescue of life on our shore. It is perfectly natural that in the excitement of such a storm as that of last week spectators should lose their heads, ad unthinkingly interfere with the work the Brigade. Now that the inconvenience has been pointed out, we trust the crowd will take upon themselves the privilege of protecting the Brigade in the discharge their duty when the misfortunes of storm-tossed mariners next call them to the beach. But, as Mr Malcolm very truly says," no amount of writing will prevent the risk of crowding when a wreck is on shore. Although the curious are put upon their honour, something more is needed to give honour force. This was foreseen in the first Brigade established, and, as was pointed out in our history of the rise of the Life Brigades, yesterday, a rule was adopted which provides for the appointment of a number of men to protect those engaged with the rocket. The South Shields men will have to face the question in this practical form, and we have no doubt that the increased protection which it will afford, and the increased consideration from people generally which Malcolm's appeal is certain to produce, will prevent any room for complaint in the future. The South Shields Brigade has a record of rescues behind it which places in the foremost of rank such institutions—a rank which it is certain to maintain for so long there are stormy seas there will be brave men amongst us 'always ready ' to face them when there is need.

THE SOUTH SHIELDS LIFE BRIGADE AND THE PUBLIC

To the Editor the Shields Daily Gazette

Sir, —Now that the excitement in conn action with the recent storm has somewhat subsided, I trust you will give me space for few remarks especially as to the crowding of the public on the pier and the sands at shipwrecks. Under the exciting circumstances no amount of writing will prevent this. People will be attracted thither from a variety of causes, but it must occur to all sensible persons, after a moment's reflection, that the efforts of the Life Brigade should not be impeded those who, from impulsive curiosity, press upon them to see what being done.

In the case of saving the crew of the Isis, October 23, when the apparatus had to be worked the surf, the onlookers did not give room even to run the whipline on the dry sand, but came themselves to the water's edge and beyond. Every time a poor fellow was landed from the wreck there was a regular stampede over the brigadesmen and gear to see what he was like. At the wreck of the Harry Clem, at 8 p.m. the same day, a denser crowd collected, trampling over the ropes that were laid on the sand, and surrounding the rocket cart in such numbers that some of the members could with difficulty find it. Two rockets were thrown on board, but one of the crew told me none of their number knew what to do with the lines. They launched their boat, which a sea half filled, and managed to drift ashore in safety. This was an intense relief to us, for had their lives depended upon our efforts, we could have done very little for them, the gear being such a hopeless mass of entanglement from the cause above-mentioned. When life and death are trembling in the balance, when every moment is precious, and when every nerve is being strained by the rocket party to bring their efforts to successful issue, 'the public should be the last to give any possible cause for failure. The melancholy sequel to all this as seen in the five unfortunate spectators who should have been at their own firesides instead of being brought lifeless to the Brigade House is a lesson which, I trust, all concerned will take to heart. From what I know the number of victims might easily have been hundred.

In addition to the Coastguard, the Board of Trade some time ago invested two of the brigade officers with powers under the Merchant Shipping Act to deal with persons impeding or in any way interfering with the working of the rocket apparatus at wrecks. The offending parties are liable to a penalty of £50. My object in writing is to give this matter publicity, so that spectators at any future wrecks may know the responsibility they incur. I trust, however, that the "powers that be" may never have cause to put their authority to the test, but that the feelings of our common humanity will be sufficient to cause one and all to do nothing to jeopardize the lives of our fellow-creatures who, alas, are so often cast upon our shore,—I remain, yours faithfully,

Sir,

In reply to your letter (M 17390) requesting to be informed what defects had been found in the present helmet shaped caps. I have the honour to state that they are made a light drab water proof cloth with a good peak before and behind and applets' at the sides for covering the ears and tying under the chin in stormy weather. The material is tolerably water tight but soon becomes dirty and misshaped and gives a generally untidy appearance to the members. The original shape is all right and the hat is comfortable to wear. I think if a white stiff glazed material could be obtained it would *asunder* the purpose better.

I have also enclosed reports as to the wreck of the "Johanna" "Wonga" "Isis" and "Harry Clem". We had a fearful storm here last week and I have much satisfaction in reporting the the South Shields Volunteer Life Brigade stuck manfully at their posts during many trying hours.

LETTER TO THE BOARD OF TRADE REGARDING THE GUN INVENTED BY LOW & DUFF

December 13th 1882

Sir,

I have the honour to acknowledge the receipt of your letter (M29746) inclosing copy of letter from Messer's Duff & Low to you and also one from me to them.

In reply to your request I have to state that the meaning of my letter has been misconstrued which is perfectly excusable owing to the usual enthusiasm of inventors.

From my official position in the South Shields Brigade and from my 17 years' experience of shipwrecks on the Coast. I have been designedly careful in giving an opinion either verbal or written as to the merits of Messer's Low & Duffs gun for Life Brigade Service and while stating that it is admirably adopted for throwing a line as exhibited in the trials of Tynemouth, yet that is a totally different thing from being admirably adapted for doing the same at shipwreck.

Messer's Low & Duffs application to me was to purchase a gun for the use of the South Shields Volunteer Life Brigade and my reply was the only one that occurred at the time of writing, and was merely a hurried note, neither intended nor expected by me to be copied and forwarded to the Board of Trade, but merely a guide them as to the steps they should take in the interests of their invention.

That being so it would be premature to say whether or not, or under what circumstances it would sail better than the present Rocket.

Although I have formed an opinion yet my idea is that you will probably some official trial as in the case of another inventor a few years ago, either at Shoebury ness or perhaps here. If the latter then I shall be very glad to report as to its merit or otherwise.

Apart from the question of the use of the invention at wrecks. I wish to repeat what I said in my letter to Messes Low &Duff that having seen it used at before mentioned trials I think it is admirably adopted for throwing a line and would be most useful for ships at sea, and also under certain conditions for a stranded vessel communicating with the shore.

It will burn for 20 minutes, If this considered too large, a vessels blue light might answer the purpose; this is easily ignited and will burn in any weather.

If this done as soon as the last man is into the lifeboat it would avoid the unnecessary labour and anxiety which the Brigade have been subjected to not only at the recent Wrecks but from former occasions.

When the Waggon is inside there is hardly room to move about and the Coastguard continually complain that they have no proper place to dry the Gear. After the numerous wrecks we had in December it was 3 weeks before the ropes were in proper working order.

The enclosed tracing shows the existing buildings when they were enclosed with the Iron Railings. I arranged them so that this Extension might be carried out without having to apply for additional ground as shown in Red.

Sir,

I have seen the Plan of the Proposed New Rocket Cart House in substitution for the present wooden building and take the liberty of pointing out a few things which I think require further consideration.

The desire for a change is because the existing house is too small. To condemn it and build a new one is, I submit a dear way of only procuring 6 feet additional length. We have the ground and it would be a great pity not to take full advantage of it. The accommodation proposed in the Brick building is not sufficient for this important Rocket Station.

I pointed out in my letter to the late Commander Denny the difficulty the Coastguard have in drying the Gear after wrecks. My plan suggested an additional room of wood for this purpose which could however be of brick. The present house with some repairs at the ground line will last a few years yet and when unfit for use could be replaced with a brick building in continuation of the room now proposed. I also think it would be better to defer the alteration till the spring not only because the "wreck season" is near but also because it is the worst time to build brickwork. I return my tracing with the Brick House shown in Red. for comparison. Our Brigade House is somewhat ornamental in appearance and the new house should have a similar character. In any case the window nearest the Brigade House should be removed to the opposite side and a small doo substituted as at present.

The Design for which Tenders have been asked is probably found to answer in size and appearance for the generality of places but this station is an exception for the reasons stated above.
